- ** Air fares Taxes and surcharges are subject to change without notice.**
- ** Exchange rate is subject to change and is finalised by prompt payment of final invoice. You can lock your exchange rate in by early payment in full. Doing so will affect any refund calculation in event of cancellation.**
- ** Cancellations and amendments are subject to supplier and agent fees. Niseko Ski Tours acts as agent. Supplier charges can vary from time to time and may change without notice.**

DEPOSIT - A standard deposit of \$500 per person is due at time of booking.

An ADDITIONAL deposit to cover cancellation vendor deposit/ cancellation policies may be required for some arrangements. The balance of the tour fee is due 70 days prior to departure or upon confirmation if less than 70 days remain. Early Bird bookings have earlier deadlines.

AIR CANCELLATIONS - Once ticketed, cancellation fees apply.

Japan Airlines

Before departure \$350 per person includes typical \$200 airline refund administration charge. After departure 100% cancel fee applies. No refund or credit is available on unused portion of tickets.

Japan Airlines Air Ticket Reissue

- Before departure: Airline fee of \$100, Niseko Ski Tours fee of \$130 per person applies.
